- All bids shall be subject to the approval of the Decatur City Council. The City reserves the right to reject all bids.
- **Each bidder shall submit bid deposit with their sealed bid in the amount of 5% of your total bid amount.** Bid deposit shall be in the form of a Cashier's Check made out to the City of Decatur. For the winning bidder the bid deposit shall be applied to the total bid amount and purchase. The balance of the amount shall be due no later than 10 business days after the council has approved. The truck shall be removed from property no later than 10 business days after the council has approved.
- For non-winning bidders the bid deposit will be mailed to the bidder within 10 business days after City Council approval and award.
- Please note the buyer will make all arrangements and perform all work necessary, including packing, loading and transportation of the property. Under no circumstances will the city of Decatur employees be able to assist in the packing, loading or shipping process. Please consider this when bidding. - Please note the buyer will make all arrangements and perform all work necessary, including packing, loading and transportation of the property. Under no circumstances will the city of Decatur employees be able to assist in the packing, loading or shipping

process. Please consider this when bidding. It is advised to view the vehicle before purchase.

- If the bidder would like to request maintenance records they can do so by filling out a request for information form and paying a fee of .50 per page to the City Clerk's office. However, the City will not make any guarantees as to the condition of the vehicles nor will it offer any warranties. All vehicles will be sold **"AS IS." ALL SALES ARE FINAL WITH NO REFUNDS.**
