CANCELLATION: After September 1, 2009, participants registered for a complimentary room must notify Jenny Holden at (865) 215-1161 of any cancellation no later than 48 hours prior to the event. ETPA will make a good faith effort to fill the vacancy from the waiting list and the cancelling agency will incur no charge. HOWEVER, if the vacancy cannot be filled, the participant's agency will be invoiced for the cost of the unoccupied room(s) at a rate of \$83.00 per night, per room, plus applicable hotel/motel tax. This same cancellation policy shall apply in the event of no-shows.

This week Business spotlight is on **GFT -Gillespie Financial and Tax Service**
